❖ Specifications for a Digital Mobile X-Ray Unit:

1. POWER SUPPLY: 110 +/- 10% VOLT AC, 60 HERTZ, SINGLE PHASE
2. WITH BATTERY-OPERATION
3. WITH FLAT PANEL DETECTOR, WIRELESS TYPE WITH TWO BATTERY AND EXTERNAL BATTERY CHARGER.
4. MOTORIZED
5. X-RAY GENERATOR:
 - Microprocessor controlled high frequency inverter type and the output of 15 KW or above.
 - It should have a digital display of mAs and kV and an electronic timer.
 - KV range: 40kV to 125kV or more.
 - mAs range: 0.32 – 200 mAs
 - Exposure time range: 0.001 – 10 s
6. X-RAY TUBE:
 - Dual Focal spot: 0.7 or less/1.3 mm or better
 - Rotating anode. Max 125 KV
 - Heat storage capacity of the anode: 300 KHU or better
 - Tube column rotation range should be +/- 270 degrees
7. CONNECTIVITY:
 - Fully network-ready
 - Compatible with the Hospital's PACS System
 - Compatible with DICOM
