SECOND REGULAR SESSION, 2024

AN ACT

To appropriate the sum of \$28,283 from the General Fund of the State of Yap for the purpose of providing funding to fund activities and programs relating to the 2024 Yap Day Celebration during Fiscal Year 2024, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

- Section 1. The sum of \$28,283, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the State of Yap for the purpose of
- 4 providing funding to fund activities and programs related
- 5 to the 2024 Yap Day Celebration during Fiscal Year 2024.
- 6 Section 2. <u>Conditions and Restrictions</u>.
- 7 (1) The sum appropriated by this Act shall not
- be advanced to any agency. Memorandum of agreement (MOA)
- 9 or other forms of agreement the purpose of which is
- 10 to obligate and disburse to the agency any amounts
- 11 from the sum appropriated herein, including
- 12 reimbursements for payments is prohibited.
- 13 (2) All funds appropriated by this Act shall be
- 14 maintained under the authority of the Director of the
- 15 Office of Administrative Services.
- Section 3. <u>Allotment and Management of Funds, and</u>
- 17 <u>Lapse Date</u>.
- 18 (1) The sum appropriated by this Act shall be

1 allotted to the Governor, or his designee.

2 (2) The Governor shall be responsible for 3 ensuring these funds are used only for the purpose 4 specified under Section 1 of this Act. The sum 5 appropriated by this Act shall be administered in 6 accordance with the provisions of applicable law, including, but not limited to, the State Financial 7 8 Management Act of 1983. The authority to obligate the 9 funds appropriated by this Act shall lapse as 10 September 30, 2024. Any part of the funds appropriated 11 by this Act not obligated by September 30, 2024 shall 12 revert to the General Fund of the State of Yap. 13 Section 4. Reports. The Governor shall ensure 14 submission to the Legislature the performance financial reports, including revision to the Yap Day 15 16 Plan, pursuant to the requirements in Section 802 of 17 Title 1 in the Yap State Code for the Yap Day Committee. 18 Section 5. This Act shall take effect upon the 19 approval by the Governor, or upon its becoming law 20 without such approval.
