DUTIES:

Responsible for the enforcement of all states and FSM laws and Municipal ordinance. Coordinates the efforts of his patrolmen with the activities of the other watches and divisions and shall seek the assistance of them when needed to foster department cohesiveness. Respond to cases and also interviews complaints frequently for the purpose of observing and/or learning of the manner in which patrolman respond to and handle their cases, noting their degree of promptness, effeciency and competence. Promptly conduct the proper investigations, submits the appropriate reports, and recommends actions to be taken in all matters brought to his attention in which complaints from any other source are registered against any officer for alleged violation of any orderpolicy, rule or regulations. Ensures that reasons for the absences are valid and submits finding to his superior. Takes suitable disciplinary actions patrolman who are guilty of dereliction of duty. Supervises any patrolmen of other divisions in the absence of their own supervising officers. Supervises all emergency operations in a calm and expedient manner until relieves by a superior. Ensures that his superior os advices of all such emergencies. Strives to involve citizens in crime prevention programs and efforts. Performs other related duties as required and assigned.

MINIMUM QUALIFICATION REQUIREMENT:

Be at least 21 years of age, possess a valid driver's license. Have no felony conviction within five years preceding to date of application, or more than three misdemeanor convictions (excluding traffic citations, by any court for a period of ten years preceding date of application. Further, not more than two moving traffic violations within one year prior to date of application. Complete a medical examination after which a physician certifies that the applicant is free from any physical defects which would adversely affect the applicant's performance as a Public Safety Officer. Take a physical fitness test which requires to complete a one and half mile run in less than 14 minutes, drag or pull a 150 lbs. weight of 25 feet radius in less than one minute and swim or tread water for 15 minutes long. Have satisfactorily performed at the Patrol Corporal Officer rank level for a minimum period of one year and successfully completed a regional 9 weeks basic training course or had graduated from a Police Academy Institute for 9 weeks training course.
