The Department of Education will continue to assist students and families with student bus fares for the school year of 2025-2026. Starting July 08, 2025, parents or guardians with their students are urged to come and fill out an application at Data Management Office.

Bus pass applications are available at the Department of Education in Data Management Office until Friday, July 25, 2025 from 9:00 am until 4:00 pm. For new applicants, whom this will be their first time to apply for a bus pass, a parent or guardian and the student must be present in order to complete the bus pass application. If a student was issued a bus pass last school year 2024-2025, only a parent or guardian can come in and sign for their student's application. Changes in the bus pass eligibility are a student must be register to their school district unless, they are attending Yap High School. Eligibility for bus fare assistance will be determined during the registration or after a bus pass application is filled. Parents or guardians will be informed after registration ends if an application did not meet eligibility requirements. If an application results in the issuance of a bus pass, it will be distributed to the students at their respective schools by the first day of instruction.

Due to the Department's limited funds, applications received after July 25, 2025 will not be accepted. Student and families are responsible for the safekeeping of bus passes.
